

### **Resume of Guido Walcher<sup>1</sup>**

I am a descendant of an old Aryan family of civil servants, born on 30 November 1893 in Vienna, where I also married. I studied at the District Teachers' School (*Landeslehrerseminar*) in Vienna for three semesters, completed a course at the Vienna Commercial Academy (*Wiener Handelsakademie*), passed the auditor's exam in 1923, and obtained a commercial engineering degree (*Diplome d'ingenieur commercial*) at the *École du Génie*.

From 1912 until the outbreak of World War One, I volunteered in France and England in order to improve my language skills. After the end of World War One, in which I participated on the Russian and Italian fronts, I began working as of 1 January 1920 at the construction company of *Brüder Redlich & Berger*, in Vienna, where, as is documented by the attached reference, I worked through the end of 1924.

From the end of 1924 until June 1929, I worked as supervisor (*kaufm. Leiter*) for the construction firm of *Julius Berger Tiefbau A. G., Berlin*, in the firm's construction department (*Baudirektion*) in Brasnov, Romania, as is confirmed in the attached reference. After briefly working as an auditor for the firm's headquarters in Berlin, I was relocated to Teheran, Persia, where I was placed in charge of the firm's offices there, as documented by the attached reference, and where I remained until the fall of 1931.

My contract was subsequently cancelled, supposedly because no further work was available. However, in reality, I lost my job because I drafted writings against the "Jewish gold monetary system" (*das jüdische Gold-Geld-System*) and international finance Jewry (*Finanzjudentum*), and sent these indictments to the League of Nations and various governmental representatives in Teheran. The original writings can be viewed for purposes of verifying my claims. I am also attaching as evidence a copy of a letter dated 1 December 1930 from the (former) office of the Federal Chancellor to the Austrian Consulate in Teheran.

After I returned to Austria, I became a member of the Nazi Party (*NSDAP*). As no permanent position was available, I returned to working as an accountant, using the certification I obtained in 1923. However, I have until today, despite repeated attempts, neither been able to be sworn in by the courts as an accountant, nor to obtain a position as accountant with the state financial authorities (*Finanzlandesdirektion*).

Due to my repeated publication – up until the Nazi Party was banned – of essays in then-Aryan newspapers, in which I tried to reveal the economic harm caused by the Jewish financial system (*jüdische Finanzsystem*), I was boycotted by the commercial and industrial communities (*Handels- und Industriekreisen*), which were, after all, almost entirely in Jewish hands, so that I was unable to find work as an accountant. Only during the past three years have I been able to find auditing work with various mid-size Aryan firms, but the pay barely suffices to survive.
